Dear Governor Tom Wolf ,

As a citizen of family & friends in law enforcement & security, and I also have PTSD, I have had serious concerns and worries these past several weeks.

I have not heard what is going on with the ruptured Sunoco Gas pipeline that may have further endangered the Susquehanna River here in Pennsylvania, and may have poisoned drinking water for parts of Pennsylvania. 55,000 gallons of gas spilled into Wallis Run Creek. Sunoco claims there is no risk to public health - yet I don't trust them. Here's why - Sunoco is a major backer of the Dakota Access Pipeline with the WORST record when it comes to pipelines according to REUTERS - look it up. The Dakotas are a WARZONE. It's painful to talk about. I am very concerned and worried that friends and relatives of mine who are in law enforcement and whom are security officers may be forced to head out to North & South Dakota to assist Morton County and other agencies against peaceful, unarmed water protectors/protestors. I feel concerned for the health and overall wellbeing and safety for all involved - the police brutality, violation of civil rights, violation of international laws, including a treaty, etc is wrong , and the violence has been escalating - people have been injured, many severely. Lies have been told by many hiding behind badges, in uniforms, and law enforcement has become militarized. I have family and friends I may never be able to see out there because of this. Please don't allow our officers to be forced to go. Mediation, not militarized police attacking unarmed people is needed most. There is NO honor in attacking an unarmed, peaceful person.

Compassion, empathy, respect is needed most.
