Position Description

The Policy Analyst will develop and implement a long-term plan to address the negative impacts to the Delaware River Watershed from proposed natural gas and gas-related pipeline projects.

Responsibilities:

- Partner with outside experts and consultants to identify the watershed impacts of specific proposed natural gas pipelines or other fossil fuel infrastructure and use the data to develop tools such as maps, fact sheets, and online resources.
- Research best practices and policies for watershed protection from pipelines and other fossil fuel infrastructure and assess the feasibility of applying the policies to the Delaware River Watershed.

- Collaborate with other groups to develop a watershed-wide plan to address the negative impacts to the Delaware River Watershed from proposed natural gas and gas-related pipeline projects.
- Work with associated groups to implement, monitor and evaluate the watershed protection plan on a regular basis.

Qualifications

- At least one year of experience in policy or planning.
- Undergraduate or graduate degree in urban and regional planning, environmental policy, environmental studies, or a related field.
- Experience writing technical reports.
- Experience working with GIS.
- Excellent research, written and oral communications skills.
- Experience engaging multiple stakeholders in a planning process.
- Background with air and water quality issues a plus.
