4a) - Outdoor Air Quality Education (Expenses: \$910,591): Clean Air Council maintained its program to address the air quality impacts of Marcellus Shale natural gas extraction, processing, and transmission. It continued its work with communities throughout Pennsylvania to address the air quality and environmental impacts from a number of proposed natural gas transmission pipelines and pipeline expansions. Clean Air Council also continued to spearhead the Protect our Children coalition to prevent new natural gas fracking operations from being sited in close proximity to schools. In Pittsburgh the Council, as part of a collaborative, pushed for major polluting facilities to clean up their facilities. In addition, the Council worked with residents of Northampton to oppose the Northampton Generating Plant from being permitted to increase its emissions of lead.

4b (Code:) (Expenses \$ 676,184 including grants of \$) (Revenue \$)

4b) - Transportation Education (Expenses: \$676,184): The Council continued to oversee the long-term development of the Cobbs Creek Connector multiuse trail in Southwest Philadelphia. The Council promoted and expanded use of its GoPhillyGo regional multi-modal mapping website, which offers a tool to help people plan recreational trips via some combination of transit, biking, and/or walking. Clean Air Council encouraged Philadelphia employees to commute sustainably to work through its Mobility Alternatives Program (MAP) and began a separate campaign under MAP that focused on reducing emissions and congestion along the I-95 highway, which is undergoing major renovations. Lastly, the Council held its first National Bike to Work celebration in South Philadelphia and began installing artistically designed bike racks in Philadelphia neighborhoods.

4c) - Public Awareness Events (Expenses: \$269,896): On September 13, 2015 Clean Air Council held the 10th Annual Greenfest Philly. This street festival, which aimed to educate the public on how to live more sustainably, took place in South Philadelphia's Headhouse Square. Thousands enjoyed the event which featured exhibitors offering environmental services or products; a green beer garden; a bike valet; Kids' Corner; a rock-climbing wall; and live music from local artists. It held its 2nd Annual Dine Out For The Environment on October 15, 2015 with 16 local sustainable restaurants participating. Clean Air Council held its 35th Annual Run for Clean Air on April 16, 2016. The event now includes a 10K race, a 5K race, a 3K walk, and Kid's Fun Runs. This year the Council awarded all participants a metallic finisher's medal that could be used as an eating utensil. With over 2,000 partic. the Run cont'd to be a popular event and the largest Earth Day race in the area.
