4a (Code: ) (Expenses \$ 1,194,493 including grants of \$ ) (Revenue \$ ) Outdoor Air Quality Education (Expenses: \$1,194,493): Clean Air Council maintained its program to address the air quality impacts of Marcellus Shale natural gas extraction, processing, and transmission. It worked with communities and landowners throughout Pennsylvania to address the air quality and environmental impacts from a number of proposed natural gas transmission pipelines and pipeline expansions. Clean Air Council also spearheaded the Protect our Children coalition to prevent new natural gas fracking operations from being sited in close proximity to schools. In Pittsburgh the Council, as part of a collaborative, pushed for major polluting facilities to clean up their facilities. In addition, the Council worked with residents of Bucks County to oppose the building of the Elcon hazardous waste treatment plant.

4b (Code: ) (Expenses \$ 705,015 including grants of \$ ) (Revenue \$ ) Transportation Education (Expenses: \$705,015): The Council continued to oversee the long-term development of the Cobbs Creek Connector multiuse trail in Southwest Philadelphia. The Council promoted use of its GoPhillyGo regional multi-modal mapping website, which offers a tool to help people plan recreational trips via some combination of transit, biking, and/or walking. Clean Air Council encouraged Philadelphia employees to commute sustainably to work through its Mobility Alternatives Program (MAP), including a separate campaign under MAP that focused on reducing emissions and congestion along the I-95 highway, which is undergoing major renovations. Lastly, the Council installed more artistically designed bike racks in Philadelphia neighborhoods and encouraged heavy duty fleets in Philadelphia to stop idling their engines.

4c (Code: ) (Expenses \$ 332,101 including grants of \$ ) (Revenue \$ ) Global Warming Education (Expenses: \$332,101): Clean Air Council organized Pennsylvania residents and litigated in support of the U.S. Environmental Protection Agency's Clean Power Plan rule, which regulates carbon emissions from existing power plants. Additionally, the Council advocated for Pennsylvania to establish best-in-the-nation methane emission standards and for federal and state laws to address methane leaks from oil and gas facilities.

**01. Form 990 governing body review (Part VI, line 11)**

A draft of the 990 is supplied to the Executive Director and the CFO. They review it and present it to the Board of Directors for approval.

**02. Conflict of interest policy compliance (Part VI, line 12c)**

The organization periodically reviews its policies regarding conflict of interest and whistleblower by discussing them at staff and Board meetings. Board meetings are also when any compensation raises for the Executive Director are discussed and approved.

**03. Form 990 availability to public (Part VI, line 18)**

The Organization makes the 990 and its annual audited financial statements available to anyone who visits the website, as they are available for download directly from the site.
