4a) - Outdoor Air Quality Education (Expenses: \$1,096,353): Clean Air Council maintained its program to address the air quality and environmental impacts from Marcellus Shale natural gas extraction, processing, and infrastructure. It sued pipeline operators whose activities threatened neighboring communities along the Delaware River. In North Philadelphia, the Council began work on community-based air quality monitoring for residents living near industrial sites. In Pittsburgh the Council educated, trained, and coordinated community groups to take action on major sources of air pollution in their neighborhood through the Southwest Pennsylvania Neighbors for Clean Air initiative. It also reviewed and commented on air quality permits for major sources of pollution in the Pittsburgh region.

4b) - Transportation Education (Expenses: \$739,587): The Council continued to promote use of its GoPhillyGo regional multi-modal mapping website, which offers a tool to help people plan recreational trips via some combination of transit, biking, and/or walking. It also continued to oversee the long-term development of the Cobbs Creek Connector multiuse trail in Southwest Philadelphia. Clean Air Council encouraged Philadelphia employees to commute sustainably to work through its Mobility Alternatives Program (MAP), including a separate campaign under MAP that focused on reducing emissions and congestion along the I-95 highway, which is undergoing major renovations. Lastly, the Council organized a Love To Ride Challenge for Philadelphia to get as many people in the region to ride their bikes and it began its #NOTAPARKINGSPOT campaign to compile a list of crosswalk and sidewalk locations that are unsafe for pedestrians.

4c) - Global Warming Education (Expenses: \$275,291): Clean Air Council brought suit against the Trump Administration for its wholesale rollback of policies designed to address climate change. Additionally, the Council successfully advocated for Pennsylvania to establish stronger methane emission rules from new and modified sources and pushed for similar regulations for existing methane sources. The Council also held Summer Heat workshops designed to educate underserved communities of color in Philadelphia on how to cope with the impacts of climate change.
