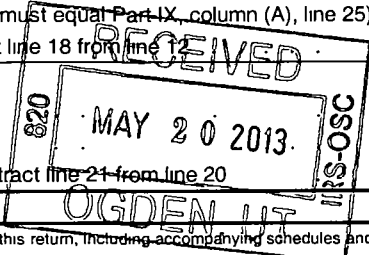

Transportation Education : Clean Air Council continued its work with reducing diesel emissions through its Green Ports Campaign and Philadelphia Diesel Difference and Delaware Diesel Difference programs The Council replaced 18 older trucks in fleets that serve area ports with newer, cleaner trucks. The Council also oversaw a project to electrify refrigerator cargo containers at Trinity Distrib. Services in Wilmington. This enabled the units to run on electricity rather than diesel engines, decreasing pollution significantly. The Council also worked on completing its Alternatives Analysis and Conceptual Design study of a proposed multiuse trail along Cobbs Creek in Southwest Philadelphia.

Air Quality Education : Clean Air Council continued its campaign to address the air quality impacts of Marcellus Shale natural gas extraction and processing. As part of this work the Council reviewed natural gas drilling permits to ensure that they comply with federal and state air quality regulations, litigated where it found drilling companies to be in violation of air quality laws, organized the public to attend regulatory hearings concerning natur.gas drilling activities and testified before regulatory agencies on proposed rules that would impact natural gas drilling. Clean Air Council also began coordinating the Pennsylvania Mom's Clean Air Force Campaign, which organizes parents to protect children's health from air pollution.

Indoor Air Quality Education: Clean Air Council still has the region's only active Indoor Air Quality Resource Center and received 3 - 5 calls a week from the public concerning indoor air pollution. Under its "Young Lungs At Play" initiative, the Council reached out to municipalities to make playgrounds and parks smoke-free and worked with students to mentor younger children not to start smoking.

This street festival, which aimed to educate the public on how to live more sustainably, took place in South Philadelphia's Headhouse Square. Thousands enjoyed the event which featured exhibitors offering environmental services or products; "Green Innovators," which were a select group of start-up organizations with compelling missions of sustainability; electric vehic.test drives; a Kid's Zone; and live music

Clean Air Council held its 31st Annual Run for Clean Air on April 21, 2012 on Martin Luther King, Jr. Drive near the Philadelphia Museum of Art. New for 2012 was a 3K Walk. With over 1,900 runners and walkers registered, the Run continued to be a popular event &the largest Earth Day race in the area. The race continued to be green certified and generated nearly zero waste. The race raised over \$102,000, for a net income of \$53,000.
