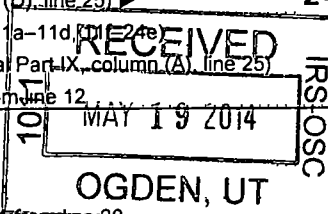

4a) - Air Quality Education (Expenses: \$571,536): Clean Air Council continued its campaign to address the air quality impacts of Marcellus Shale natural gas extraction and processing. As part of this work the Council reviewed 20 natural gas compressor station permits to ensure that they followed air quality regulations, litigated where it found drilling companies to be in violation of air quality laws, organized communities across Pennsylvania to take action locally on fracking activities that impacted their neighborhoods, and testified before regulatory agencies on proposed rules that would impact natural gas drilling. Clean Air Council also began work on addressing air pollution from biomass facilities by reviewing nearly 20 wood-burning facilities to determine whether they were

4b) - Global Warming Education (Expenses: \$176,567): Clean Air Council provided information to the public on global climate change, particularly the health and environmental impacts it will have on the region. The Council organized 14 high visibility public events in support of laws and regulations that would result in carbon emission reductions. The Council worked in Delaware to decrease greenhouse gases from the transportation sector by overseeing the repowering of a Port of Wilmington tugboat with a newer, cleaner engine; by promoting heavy duty vehicle idling reduction; and by encouraging commuters to reduce their carbon footprint by car-pooling or using mass transit.

4c (Code:) (Expenses \$ **276,140** including grants of \$) (Revenue \$)

4(c) - Transportation Education (Expenses: \$276,140): Clean Air Council continued its work with reducing diesel emissions through its Philadelphia Diesel Difference Working Group. The Council completed its Alternatives Analysis and Conceptual Design study of a proposed multiuse trail along Cobbs Creek in Southwest Philadelphia and will move forward on developing the final design for the trail. Through its Commuter Connection program, the Council promoted multi-modal methods of travel (combining transit with walking or cycling along trails) in order to commute to employment locations that traditionally people drive to.

On September 9, 2012 Clean Air Council held the 7th Annual Greenfest Philly. This street festival, which aims to educate the public on how to live more sustainably, took place in South Philadelphia's Headhouse Square. New for 2012 were a "green beer garden" and a scavenger hunt that further educated attendees about exhibitors' green initiatives. Thousands enjoyed the event which featured exhibitors offering environmental services or products; "Green Innovators," which were a select group of start-up organizations with compelling missions of sustainability; a Kid's Zone; and live music. Clean Air Council held its 32nd Annual Run for Clean Air on April 20, 2013 on Martin Luther King, Jr. Drive near the Philadelphia Museum of Art. While the Run course was the same as in prior years, the accompanying Earth Day festival was set up in front of the Museum for the first time. New for 2013 was a Kid's Fun Run. With nearly 2,500 runners and walkers registered, the Run continued to be a popular event and the largest Earth Day race in the area. The race remained green certified and generated nearly zero waste. Also, participants who switched their electricity to 100% solar and wind ran for free. The two special events combined to raise about \$120,000 for the Council.
