Re: Aquashicola/Pohopoco Watershed Conservancy's Petition to Redesignate Aquashicola Creek to Exceptional Value (EV) Cold Water Fishery

It is my pleasure to write in support of the Aquashicola/Pohopoco Watershed Conservancy's petition to redesignate the Aquashicola Creek from High Quality Cold Water Fishery (HQ-CWF) to Exceptional Value Cold Water Fishery (EV-CWF). The Conservancy seeks protection for this jewel of our Pennsylvania waters for several compelling reasons.

As mentioned in the original petition, submitted to the Pennsylvania Department of Environmental Protection in 2010, the upper section of the Aquashicola Creek remains relatively underdeveloped and links to several preserved tracts of land, including sections of Cherry Valley National Wildlife Refuge, as well as runs parallel to the Kittatinny Ridge and the Appalachian Trail. The Aquashicola Creek runs through protected wetlands, and sections of the Creek have received designations as Class A Wild Trout Stream and Naturally Reproducing Trout Stream. Scientific samplings of the macroinvertebrate population have also suggested this area could be upgraded to exceptional value.

Since 2010, the contested land that of Alpine Rose that was under litigation has been settled and is now designated as part of State Game Lands 168, which is also the site where a species of dragonfly, the Brook Snaketail, was discovered for the first time in PA. One thousand acres have been added to State Game Lands 168 upstream from the property, on both sides of the creek. A major tributary, the Ross Common Creek, is located entirely within the Cherry Valley National Wildlife Refuge, the boundary of which extends approximately eight miles downstream along the Ross Common and Aquashicola Creeks.

For these compelling reasons, I ask that you give the Aquashicola/Pohopoco Watershed Conservancy's Petition to Redesignate Aquashicola Creek to Exceptional Value (EV) Cold Water Fishery your full and fair consideration. Thank you in advance for your thoughtful deliberation.



Dear Mr. Lookenbill:

The Aquashicola-Pohopoco Watershed Conservancy is petitioning the EQB to redesignate the upper reaches of the Aquashicola Creek, from the headwaters to the confluence with Buckwha Creek, from its current designation of HQ-CWF to Exceptional Value. This redesignation is supported by the presence of exceptional value wetlands, designated as such due to the presence of threatened/endangered plants and animals. The stream's watershed is still undeveloped, and includes preserved lands including the Cherry Valley National Wildlife refuge and state gamelands; sites of specific historical significance are also present. A portion of stream itself has been designated by the PA Fish & Boat Commission as a Class A Wild Trout Stream and Naturally Reproducing Trout Stream. And the biological data collected by local experts and by the PADEP itself support this upgrade.

Recent developments that further support the Exceptional Value designation include the preservation of land in the watershed, the finding of a rare species of dragonfly, and the settlement of the Alpine Rose litigation, which fundamentally threatened the health of the watershed as a whole, and of the creek specifically.

The Aquashicola-Pohopoco Watershed Conservancy is a member of the Watershed Coalition of the Lehigh Valley, and at our July 8<sup>th</sup>, 2020 Board Meeting, the WCLV Board of Directors unanimously voted to support this petition.



Delaware Riverkeeper Network submits this letter on behalf of 216 individuals who have signed on in support.

Over a decade ago, the Delaware Riverkeeper Network (DRN) supported a petition submitted by the Aquashicola – Pohopoco Watershed Conservancy (APWC) to redesignate the Aquashicola Creek in Monroe and Carbon counties from HQ-CWF to EV status. In the decade that has passed since the submission of this petition, several development projects have arisen that have threatened the water quality of the Aquashicola while the petition remains pending. DRN and the APWC have been successful in protecting the Aquashicola from some of these threats such as the proposed Alpine Rose racetrack, which was defeated in 2013. However, new threats continue to arise such as the proposed 68 mile Phase 1 of the PennEast Pipeline, which would directly cross the Aquashicola Creek and negatively impact water quality.

The Aquashicola Creek is deserving of EV designation because it exhibits high macroinvertebrate scores and exceptional ecological significance. The watershed contains several drinking water intakes and runs through several contiguous preserved tracts of land, including sections of the Cherry Valley National Wildlife Refuge and PA State Game Lands 168. It also runs parallel to the Appalachian Trail and Kittatinny Ridge, a world-famous Migratory Corridor of the Atlantic Flyway, and portions of the creek are designated as a Natural Reproduction Trout Stream and Class A Wild Trout Stream by the PFBC. Finally, the Aquashicola Watershed contains EV wetlands that are confirmed habitat for the federally threatened bog turtle.

There is great community interest in protecting this important resource. For over a decade, DRN and the APWC have been part of a statewide EV coalition that is dedicated to upgrading deserving streams throughout the Commonwealth to EV status. We have also been monitoring water quality and collecting data on the Aquashicola Creek during this time, including the deployment of DIY sensors. The longer the petition remains pending, the more vulnerable the Aquashicola Creek is to the growing list of threats from major development projects. The Pennsylvania Environmental Rights Amendment was designed to preserve every Pennsylvanian's right to clean streams and a healthy environment. A change to EV status is crucial in protecting the excellent water quality of the Aquashicola Creek so that it remains in perpetuity for future generations in concurrence with the amendment. The time has come for the Department to thoroughly review the petition in its entirety and produce a draft report with the recommendation to upgrade Aquashicola Creek to Exceptional Value status.





Dear Mr. Lookenbill:

The members of the Friends of the 1855 Frantz One-Room Schoolhouse wish to voice their support for the petition by the Aquashicola/Pohopoco Watershed Conservancy to change the designation of Aquashicola Creek from a "high quality cold water fishery (HQ)" to "Exceptional Value (EV)".

We support this change from the creek's source to its confluence with the Buckwha Creek. We believe these waters should have the highest level of protection.

Our reasons, specifically, for supporting this increased level of protection includes its location, the surrounding lands, the importance of its wetlands for threatened and endangered species of flora and fauna, and the fact that it is a "naturally reproducing trout stream".

Through intense community effort, the public has secured, through the work of dedicated stewards, significant additions to "protected" lands in the area.

This includes 1,000 acres added to SGL 168 including land on both sides of the Aquashicola. Also, land that would have previously been part of the Alpine Rose "Race" Course. And, Cherry Valley National Wildlife Refuge has added 340 acres including about a half mile of streams.

We are also concerned about the Brook Snaketail dragon fly which was recently discovered on the creek in the area of SGL 168. These are among the most environmentally sensitive dragonflies in North American and as such are outstanding indicators of water quality and overall watershed health.

The Aquashicola Creek and its wetlands play a crucial role in the world famous migratory corridor along the Kittatinny Ridge. The Audubon Society tells us that the Kittatinny Ridge is the premier raptor migration corridor in the northeastern U.S., one of the leading such sites in the world. The ridge funnels thousands of southbound migrants; lesser numbers also follow the ridgeline north in the spring. Other species in addition to raptors migrate through, including Ruby-throated Hummingbirds and Monarch Butterflies.

And finally, studies - the Monroe County Water Quality Study and the Pennsylvania Department of Environmental Protection - provide samplings supporting an upgrade to "Exceptional Value".

- Location: The upper section of the Aquashicola Creek is still relatively undeveloped. It links
  contiguous preserved tracts of land including sections of the Cherry Valley National Wildlife
  Refuge and PA State Game Lands 168. The creek also runs parallel to the Kittatinny Ridge –
  a world famous migratory corridor and the Appalachian Trail. It is also near areas of

This letter is written to confirm that the Sierra Club - Pennsylvania Chapter - Lehigh Valley Group (LVG) actively supports the Aquashicola /Pohopoco Watershed Conservancy's (APWC) request to the Pennsylvania Department of Environmental Protection (PADEP) that the Aquashicola Creek, from its source to its confluence with Buckwha Creek, be given the highest level of protection, Exceptional Value (EV) status. The Aquashicola Creek lies within our Group's membership area.

The Sierra Club - LVG agrees that the current designation, High Quality Cold Water Migratory Fishery, does not accurately reflect the value of this stream or provide enough protection to the Aquashicola Creek. An Exceptional Value (EV) designation is the appropriate designation under these circumstances. The Aquashicola should be given an EV designation for many reasons. We agree with APWC that an EV designation should be applied because:

- Macroinvertebrate samplings have demonstrated a high quality aquatic community, a basis for designation as a special protection water;
- The upper eight miles of the Aquashicola Creek are within the Cherry Valley National Wildlife Refuge. This section contains Ross Common Creek, the headwaters of the Aquashicola, and various wetlands of ecological significance;
  - Surface Waters of Exceptional Significance (see below);
- PADEP, the Pennsylvania Fish and Boat Commission (PA F&B), and the US Fish and Wildlife Service (US F&W) have all determined that bog turtles, listed as endangered by Pennsylvania and threatened by the federal Endangered Species Act, inhabit the Aqushicola watershed. Under the Pennsylvania Code, 25 Pa.Code Sec. 105.17(1) (i)-(iii)), special protection is given to wetlands which serve as habitat for threatened and/or endangered species such as the bog turtle; this includes hydrologically linked wetlands and wetlands in the floodplain of the Aquashicola Creek.
- The Aquashicola Creek watershed, from headwaters to confluence with the Buckwha, is listed by Pa F&B as a Naturally Reproducing Trout Stream. A 2.2 mile segment of the Aquashicola Creek in Ross Township, from Tittle Rd. to Chicola Lake has been designated a Class A Wild trout Stream by Pa F&B.
  The Pennsylvania Game Commission has acquired 1,100 acres of land in Ross and Eldred Townships to add to State Game Lands 168. The Aquashicola Creek flows through approximately 1/2 mile of this new acquisition.

 Additional reasons for EV designation include a cluster of historic buildings along the creek in Eldred Township and the creek's proximity to Blue Mountain/ Kittatinny Ridge, which contains the Appalachian Trail National Scenic Trail and a major migratory bird corridor known as the Atlantic Flyway.

Please forward our letter of support to any appropriate agency concerning the redesignation.



The Stream Conservancy supports this petition based on three main points:


- Better protection of the wild aspects of the Appalachian trail.
